In accordance with the recommendations of the Investment Company Institute's Money Market Working Group, on a monthly basis, Lord Abbett provides information regarding concentration of ownership of shares of Lord Abbett U.S. Government & Government Sponsored Enterprises Money Market Fund (the "Money Market Fund"). The following information is current as of 5/31/2022.

The Money Market Fund, as with any money market fund, is subject to redemptions by its larger shareholders. In an exceptionally difficult market, certain funds may experience unanticipated large redemptions that may be disproportionate to the value of securities in the fund's portfolio that are liquid enough to be sold to meet such redemptions. Lord Abbett believes that because: (i) the Money Market Fund's investment policies require the Fund to invest primarily in securities issued or guaranteed by the U.S. Government and U.S. Government-sponsored enterprises, and related investments; and/or (ii) Lord Abbett is not aware of a high concentration of large institutional shareholders that are apt to make large unexpected redemptions of Fund shares, the Money Market Fund generally is less susceptible to such redemption pressures than certain other money market funds.

In addition, the Money Market Fund publishes, on a monthly basis, the percentage of Money Market Fund shares held by (excluding any accounts held by Lord Abbett or its affiliates):

- Any current shareholder of record that has transacted, or any prospective shareholder of record that will transact, on behalf of multiple beneficial
 shareholders and that holds, or after the processing of a purchase or exchange order would hold, more than twenty-five percent (25%) of the Money
 Market Fund's outstanding shares (among all share classes) (collectively, "Financial Intermediary Accounts"); and
- Any current or prospective shareholder (whether of record or, if known to the Money Market Fund, beneficially) that has not transacted, or will not
 transact, as the case may be, on behalf of multiple beneficial shareholders and that holds, or after the processing of a purchase or exchange order would
 hold, more than twenty-five percent (25%) of the Money Market Fund's outstanding shares (among all share classes) (collectively, Concentrated
 Accounts).
