How did the Fund perform last year and what affected its performance?

For the fiscal year ended October 31, 2024, the Fund returned 49.41%, reflecting performance at the net asset value (NAV) of Class A shares, compared to the 43.01% of a securities market index with investment characteristics similar to those of the Fund, the Russell Micro Cap Growth Index. The Fund's broad-based securities market index, the S&P 500 Index, returned 38.02% over the same period.

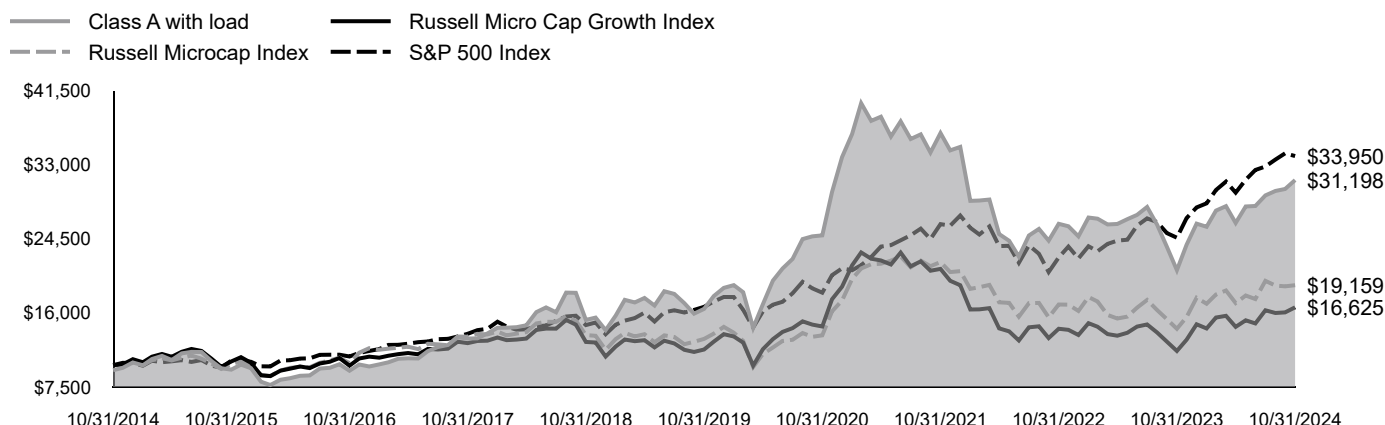
Positive factors for the markets included momentum around the soft-landing narrative, which was supported by signs of a cooling labor market and a slowing economy. This led to the U.S. Federal Reserve (Fed) lowering its policy rate by 50 basis points in September. There were also increased market expectations for further rate cuts in 2024. Mixed economic data, including softer consumer price index reports and fluctuating job market indicators, contributed to these expectations of rate cuts, and also sparked recession fears. However, these factors were mostly balanced by strong consumer spending and retail sales.

Top contributors to performance: Security selection within the Health Care sector contributed to relative performance, led by an overweight allocation to Longboard Pharmaceuticals, Inc. Security selection within the Consumer Discretionary sector also contributed to relative performance, led by an overweight allocation to Sweetgreen, Inc.

Top detractors from performance: Security selection within the Financials sector detracted from relative performance, led by an overweight allocation to Remitly Global, Inc. Security selection within the Communication Services sector also detracted from relative performance, led by an overweight allocation to Yelp, Inc.
